- 3. How does Cleanth Brooks's exploration of paradox in language challenge traditional interpretations of meaning and truth in literature?
- 4. How does Wordsworth's Preface to 'Lyrical Ballads' reflect his views on the role of poetry in society and the nature of poetic language?
- 5. How does Arnold's 'Touchstone Method' and his idea of "the best that has been thought and said" shape his approach to literary criticism and evaluation of poetry?
